(Re: The Company does not meet the conditions to be a Public Company)

1. GENERAL INFORMATION ABOUT THE COMPANY:

2. LEGAL BASIS AND THE COMPANY'S ACTUAL STATUS:

- Pursuant to Clause 11, Article 1 of Law No. 56/2024/QH15, amending and supplementing Point a, Clause 1, Article 32 of Law on Securities No. 54/2019/QH14;
- Pursuant to Official Letter No. 1474/UBCK-GSĐC dated February 24, 2026 issued by the State Securities Commission of Vietnam regarding the review of public company status;
- Pursuant to the consolidated list of securities holders (stock code: VIW) No. VNMEETVSDV009890/VSDVIWXX prepared by the Vietnam Securities Depository and Clearing Corporation (VSDC) on January 6, 2026 (record date: December 31, 2025).

As of the record date December 31, 2025, the shareholder structure of Vietnam Water and Environment Investment Corporation - JSC (VIW) is as follows:

Total outstanding shares: 58,018,600 shares.

- Major shareholder: Vietnam Construction and Import-Export Joint Stock Corporation (Vinaconex) holds 56,949,500 shares, equivalent to 98.16% of the total voting shares.



- Remaining shareholders (not major shareholders): hold 1,069,100 shares, equivalent to 1.84% of the total voting shares.

In comparison with the provisions stipulated in Point a, Clause 1, Article 32 of the Law on Securities 2019 (as amended and supplemented by Law No. 56/2024/QH15), Vietnam Water and Environment Investment Corporation - JSC (VIW) does not meet the requirement regarding the shareholder structure, “*having at least 10% of voting shares to be held by at least 100 investors who are not major shareholders.*”

3. COMMITMENTS AND REQUESTS:

In fulfillment of the obligation to review the compliance with the conditions for being a public company as requested by the State Securities Commission of Vietnam in Official Letter No. 1474/UBCK-GSDC dated February 24, 2026 regarding the review of public company status, by this document we hereby officially inform the State Securities Commission of Vietnam that **“Vietnam Water and Environment Investment Corporation - JSC currently does not meet the conditions to qualify as a public company.”**

We commit to continue fully complying with all regulations applicable to public companies (including information disclosure obligations and corporate governance requirements) until an official notification is issued by the State Securities Commission of Vietnam regarding the termination of the Company’s public company status in accordance with Clause 3, Article 38 of the current Law on Securities.

Vietnam Water and Environment Investment Corporation - JSC respectfully requests the State Securities Commission of Vietnam to review and acknowledge the current status of the Company and provide guidance on the next steps.
